- **ALL INDIA STRIKE IN UNITED BANK OF INDIA ON 9TH MARCH, 2016**
- **EXTEND ALL SUPPORT**

After exhausting all efforts to resolve the issues amicably, our United Bank of India Employees Association-Central Federation, along with other workman Unions in the Bank, has given the call for All India Strike on 9th March, 2016 on the following issues and demands:

- Scientific and rational assessment of manpower
- Recruitment of required Awardstaff for effective customer service
- Immediate promotion of substaff as SWO
- Repatriation of substaff to home State
- Implementation of pending transfers
- Unauthorised utilisation of SWO in higher work
- Unauthorized engagement of outsiders in Bank's job
- Outsourcing of Bank's job in violation of industry-level settlement

From AIBEA we have addressed a letter to the management of the Bank to resolve the issues amicably by holding discussions with the unions. In the meantime, all our units are requested to extend their support to the strike and participate in demonstrations before branches of UBI along with the agitating employees.

Our attention has been drawn to the agitational programmes undertaken by our unit viz. United Bank of India Employees Association along with all the other Awardstaff Unions and their call for strike on 9th March, 2016.

We observe that the issues and demands raised by them are very reasonable and genuine and hence need to be addressed effectively in order to enable your Bank to face the present and emerging challenges facing the Bank. It is known to all concerned – both management and the unions – that the present challenges facing the banks can be overcome only by working together as a collective team. For this, a very cordial industrial relations is imperative and conflicts are to be avoided. We are aware that you also know this and hence will appreciate the same.
